****LIMITATION OF LIABILITY****

In consideration of Corvette’N America, L.L.C., d/b/a **BLOOMINGTON GOLD TOURS** (hereinafter “Bloomington”) allowing me to participate in the Grand Canyon/Sedona Tour (the “Tour”) on October 4-7, 2012, I hereby agree to this Limitation of Liability Agreement (“Agreement”).

I am aware, understand, and accept the fact that my participation in the Tour may entail both known and unanticipated risks. I acknowledge that such risks cannot be eliminated without jeopardizing the essential qualities of the Tour. Risks associated with the Tour include, **but are not limited to:** automobile accidents; automotive theft; hazards of walking on uneven terrain and slips and falls; becoming injured or lost; negligence of other persons or animals (including, without limitation, dogs); the condition, operation and hazards associated with roads, highways, trails, vehicles, or other means of conveyance; the forces of nature, including wind, rain, lightning and rapid weather changes; the risks of falling; the risks inherent in driving; the risks of exposure to insect bites; the risks of cold, including hypothermia; food poisoning; and the physical exertion associated with participating in the Tour.

I understand that any of the above risks, dangers and hazards could result in personal injury, sickness, death, or personal property loss or damage.

In the event that Bloomington is found to be liable to any extent, or for any reason, I expressly agree that the liability of Bloomington, its agents and employees, and to all persons having contractual relationships with them, in connection with services provided hereunder to me, resulting from any negligent acts, errors and/or omissions of Bloomington, its agents and/or employees is **limited to the total fees actually paid by me to Bloomington** for services rendered by Bloomington in association with this Agreement.

I have read and understood the terms of this Agreement. I am signing it freely and of my own accord, and understand that it is binding upon myself, my heirs and assigns. If a minor will be on the Tour, I certify and warrant that I am that minor’s legal parent or guardian, and that I have full authority to execute this Agreement on that minor’s behalf. I understand and agree that this Agreement is governed by the laws of the State of Arizona. As a condition of being allowed to participate in the Tour, I agree to all terms of this Agreement.
